

Official Rules and Regulations – Financial Health Sweepstakes

Foothill Credit Union Financial Health Sweepstakes: ONE (1) prize winner will be selected weekly at random and will receive a \$100 credit to his/her Foothill Credit Union account.

At the completion of the promotional period, there will be one grand prize winner for a health themed gift basket.

SWEEPSTAKES ENTRY PERIOD: The Foothill Credit Union Financial Health Sweepstakes entry period begins Friday, May 1, 2020 at 12:01 a.m. and ends on Friday, June 5, 2020 at 11:59 p.m. (PST) (“Entry Period”). Entry into the Foothill Credit Union Financial Health Sweepstakes does not constitute entry into any other promotion. Entries received prior to or after the entry period are not eligible for the offer.

ELIGIBILITY: The Foothill Credit Union Financial Health Sweepstakes is open to all Foothill Credit Union members who are 18 years or older. Foothill Credit Union employees, their immediate family members, and Board members are not eligible for this offer. Only individual persons may participate. Registration or participation from any corporation or other entity shall not be accepted or considered valid.

HOW TO ENTER: Any Foothill Credit Union Member who completes the designated Financial Health playlist within the designated week, will be entered into a random drawing to win two a \$100 cash credit to his/her Foothill CU account. Incomplete playlists will not be counted. All entries received before or after the contest dates are void and ineligible for a prize. Playlists for the contest are designated as follow:
