

Azusa Seminar Amazon Gift Card Sweepstakes Official Rules

Sponsor:

This sweepstakes (“Sweepstakes”) is sponsored by Foothill Credit Union (“Sponsor”).

Prize:

One (1) winner will be selected at the conclusion of each seminar. Each winner will receive one (1) \$25 Amazon gift card. Total number of prizes: five (5). Approximate Retail Value (“ARV”) of each prize: \$25.

Amazon is not a sponsor of, affiliated with, or responsible for this Sweepstakes.

Odds of Winning:

Odds of winning depend on the number of eligible entries received for each Seminar Date.

Eligibility:

Open only to legal residents of the State of California who are eighteen (18) years of age or older at the time of entry. Void where prohibited or restricted by law.

Sweepstakes Period:

The Sweepstakes will take place in connection with the following seminar dates: April 16, April 20, April 22, April 27, and April 29 (each, a “Seminar Date”).

How to Enter:

Eligible individuals who attend any Azusa City Seminar presented by Sponsor and its partners on a Seminar Date will automatically receive one (1) entry into the Sweepstakes for that seminar. Attendance at multiple seminars will result in multiple entries, with a limit of one (1) entry per person per Seminar Date.

Alternate Method of Entry (AMOE):

To enter without attending a seminar, eligible individuals may mail a handwritten 3”x5” card with their full name, mailing address, email address, phone number, and the specific Seminar Date they wish to enter to: Foothill Credit Union – MAC Sweepstakes Entry, PO Box 660130, Arcadia, CA 91066. Entries must be postmarked no later than the applicable Seminar Date and received within five (5) business days thereafter. Limit one (1) mail-in entry per person per Seminar Date.

No Purchase Necessary:

No purchase or payment of any kind is necessary to enter or win. A purchase will not increase your chances of winning.

Winner Selection and Notification:

Winners will be selected at random at the end of each seminar from all eligible entries received for that Seminar Date. Winners must be present at the seminar at the time of the drawing to claim their prize. If a selected winner is not present, an alternate winner may be selected. Mail-in entrants selected as winners will be notified via email or phone and must respond within five (5) days or an alternate winner may be selected.
