

AMAZON PRIME DAYS \$100 SWEEPSTAKES

1. PROMOTIONAL PERIOD

Members who use their Foothill Credit Union Platinum Rewards Mastercard®, Platinum Mastercard®, or debit card linked to a Foothill checking account and make a qualifying purchase through Amazon during Amazon Prime Days from June 23, 2026 through June 26, 2026 will automatically receive one (1) entry into the Sweepstakes for each qualifying transaction.

NO PURCHASE NECESSARY

This Sweepstakes is open to all Foothill Credit Union members. Employees, directors, vendors, and their immediate family members (spouse, parent, sibling, child, regardless of residence) are not eligible to participate.

3. NO PURCHASE NECESSARY

Eligible transactions include qualifying Amazon purchases made using a Foothill Platinum Rewards Mastercard®, Platinum Mastercard®, or debit card linked to a Foothill checking account during the Promotional Period.

Approximate Retail Value ("ARV") of each prize: \$100.

Total ARV of all prizes: \$300.

Odds of winning depend on the total number of eligible entries received.

Prizes will be deposited into the winner's Foothill Credit Union account within thirty (30) days following verification of eligibility and acceptance of the prize.
