

Amazon Prime Big Deal Days \$100 Promotion

1. **PROMOTIONAL PERIOD:**

The promotional period for this Sweepstakes begins on **October 7, 2025** and ends on **October 8, 2025**.

2. **HOW TO ENTER:**

Limit one (1) entry per Amazon transaction. Members who use their **Foothill Platinum Rewards MasterCard, Foothill Platinum MasterCard, or Foothill debit card** attached to a Foothill checking account to make a purchase through Amazon during **Amazon Prime Big Deal Days (October 7–8, 2025)** will automatically be entered into the Sweepstakes.

3. **ELIGIBILITY:** This Sweepstakes is open to all Foothill Federal Credit Union (“FFCU”) members.

Employees, directors, and vendors of FFCU and their immediate family members (spouse, mother, father, sister, brother, daughter, or son, regardless of residence) are not eligible to participate. By entering, you agree to these Official Rules and the decisions of FFCU, which shall be final and binding in all respects. This Sweepstakes is void in states where prohibited or restricted by law.

4. **NO PURCHASE NECESSARY:**

No purchase is necessary to enter or win. A purchase will not increase your chances of winning. Sweepstakes void where prohibited, taxed, or restricted by law. All federal, state, and local laws and regulations apply. If the initial winner does not respond within this time, a secondary drawing will be conducted. Additional drawings will be held as necessary until a confirmed winner is determined.

Members who make a qualifying Amazon purchase using their Foothill Platinum Rewards MasterCard, Foothill Platinum MasterCard, or Foothill debit card attached to a Foothill checking account will be automatically entered to win one of three (3) **Grand Prizes: \$100 deposited directly into the winner’s Foothill Savings Account**. Winners will be selected on **Wednesday, October 22, 2025**, from all eligible transactions made between **October 7–8, 2025**. FFCU reserves the right to substitute prizes of comparable value.
