Automate Your Change into Savings

Our Round It Up feature operates similarly to an automated savings account. Whenever you make everyday transactions with your debit card, the amounts are rounded up to the nearest dollar, and the spare change is then moved into your designated Foothill savings account.



For example: *If you bought an iced coffee with your debit card for \$4.25, it would be rounded up to the nearest dollar which in this instance would be \$5.00. The remaining \$0.75 (difference from \$5.00 to \$4.25) would then be deposited into your savings account the next day, along with other Round It Up transactions.*

To enroll for Round It Up, login to your digital banking, and click "Round It Up" under the Accounts tab. If you'd rather speak to a Foothill representative, call us at 626-445-0950.

BEWARE OF *Scams*

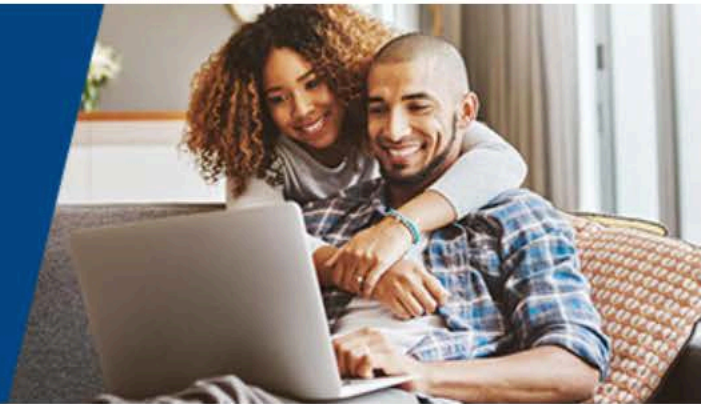


Never Share Your Password or Passcodes

To ensure your protection against financial scams, in particular Zelle® scams, here are some important pointers to maintain the security of both your funds and personal information.

- **NEVER DISCLOSE YOUR PASSWORD OR ONE-TIME PASS CODES.** Foothill will never initiate communication with you via phone, text, or email to solicit information that you've received through text (SMS). Likewise, we will not pressure you into resetting your online banking password.
- Zelle® transactions are not utilized for issuing refunds. If someone contacts you and proposes a refund through Zelle®, it is recommended to promptly end the call and get in touch with us.
- Exercise caution with caller ID information. The displayed caller ID may be manipulated to exhibit the name of Foothill CU. When in doubt hang up and call them back using a number you researched to be correct and not the one that showed up on the caller ID.
